Each year, the Housing for Health Partnership (H4HP) administers the Program Competition for HUD Continuum of Care and YHDP Renewal and Replacement funds. This calendar serves as a guide for applicants who are considering applying for new or renewal funds from HUD through the Continuum of Care and YHDP Renewal and Replacement Notice of Funding Opportunity (CoC NOFO).
